# **INDICATIONS**

For increased rate of weight gain, improved feed efficiency, increased carcass leanness, prevention and control of coccidiosis due to Eimeria bovis and E. zuernii and reduction of incidence of liver abscesses caused by Fusobacterium necrophorum and Arcanobacterium (Actinomyces) pyogenes in cattle fed in confinement for slaughter for the last 28 to 42 days on feed.

# **INGREDIENTS**

Each ingredient must be named in accordance with the names and definitions adopted by the Association of American Feed Control Officials.

# FEEDING DIRECTIONS

Feed continuously as sole ration to provide 90 to 430 mg/hd/day ractopamine and 0.14 to 0.42 mg monensin/lb body weight per day, depending on the severity of the coccidiosis challenge, up to 480 mg/hd/day and 60 to 90 mg/hd/day tylosin for the last 28 to 42 days on feed.

#### **CAUTIONS**

Do not allow horses or other equines access to feeds containing monensin. Ingestion of monensin by horses has been fatal. Monensin medicated cattle feed is safe for use in cattle only. Consumption by unapproved species may result in toxic reactions. Do not exceed the levels of monensin recommended in the feeding directions, as reduced average daily gains may result. If feed refusals containing monensin are fed to other groups of cattle, the concentration of monensin in the refusals and amount of refusals fed should be taken into consideration to prevent monensin overdosing.

Do not use in any finished feed (supplement, concentrate or complete feed) containing in excess of 2% bentonite.

Ractopamine HCl is not for animals intended for breeding.

### **WARNINGS**



A withdrawal time has not been established for pre-ruminating calves. Do not use in calves to be processed for veal.
